**Final Checks:**

- Movie uploaded on dropbox and shared with iculbertson@bgcvic.org or USB labelled with your name and number including the registration package.
- Complete and legible registration form with a photo release waiver filled out for each participant shown in the video (last page of this registration form)
- Copyright documentation attached

## Contest Rules & Submission Details

1. All submitted videos should address the topic of “Anti-Bullying” and be in the form of a Public Service Announcement (PSA). Please keep videos appropriate in nature. Entries with inappropriate content (e.g. offensive language, nudity) will not be screened.

2. Videos must be under one minute in length. Please be aware that your video will be accompanied by an introduction/acknowledgement of the host organizations.

3. The contest is open to youth living in the Greater Victoria area up to 19 years of age. As this is a youth film festival we ask that parents, teachers and other adults assisting in the production limit their involvement. Youth are responsible for the planning, filming and editing of their work. Failure to adhere to these requirements may result in disqualification from the festival.

4. All videos must be submitted via USB flash drive in .AVI, .MOV or .MPEG format, or submitted by dropbox and shared with iculbertson@bgcvic.org. The recommended quality of video is either Standard Definition (720 x 486 or 480 pixels) or in High Definition (1920 x 1080 or 1280 x 720 pixels). All submissions must include an attached registration form. 5. All entries should be submitted by no later than 12:00pm Friday, February 17<sup>th</sup>. If submitting by USB, please drop it off at one of the following locations (it will be returned to you after the event):

All eligible entries will be screened at the Youth United 2017 Anti-Bullying Film Festival event on February 22<sup>nd</sup> at l'Ecole Victor-Brodeur between 6:30pm and 8:30pm with a 15 minute intermission. Local organizations will be at the event with resources for children, youth, and families.

8. A panel of judges will assess the PSA using the following criteria (visit [www.bgcvic.org/events/events/anti-bullying-film-festival/](http://www.bgcvic.org/events/events/anti-bullying-film-festival/) for a detailed judging form):

- Clear Anti-bullying message
- Creativity/Originality
- Production Quality
- Overall Impression
